Lake Partner Program - samples away!

Lake Stewards - Don't forget: It is time to start sending in your water samples for the Lake Partner Program to the Dorset Environmental Science Centre. Your kit will indicate how often to sample:

- ◆ If your lake is "on" the Canadian Shield be sure to submit your Total Phosphorous readings for May, if you have not already done so.
- ◆ For "off" shield lakes be sure to collect and submit your Total Phosphorous data once a month, beginning in May and ending in October.

For both types of lakes, water clarity measurements should be taken with your Secchi disk once every two weeks throughout the ice-free season. These recorded water clarity measurements should be mailed back to DESC in the postage-paid envelope provided or emailed to lakepartner@ontario.ca by no later than December, 2015.



Fish Updates

Broad Scale Monitoring

In late May, FOCA sent email notices to member Association Presidents on lakes that will be sampled as part of the 2015 Broad Scale Monitoring Program of the Ministry of Natural Resources and Forestry. [Click here for a map of lakes being sampled...](#)



If you encounter sampling on your lake (marked with orange MNRF buoys), please avoid recreational activities between and around the buoys, and do not lift the nets or buoys.

Since 2008, this long-term research has been conducted to monitor the health of Ontario's lakes, to better understand the current state of fish and other aquatic resources, identify stresses on these resources, and report changes over time. New rules for ATV's start Canada Day

Beginning July 1, 2015, the province of Ontario is implementing the following changes related to Off Road Vehicles (ORV's) and All Terrain Vehicles (ATV's):

- ◆ More types of ORVs and ATVs, including two-up ATVs, side-by-side ATVs and utility-terrain vehicles (UTVs), will be allowed to use the shoulder of public roads.
- ◆ All riders - including drivers and passengers of all ages - will have to wear a helmet and use a seat belt or foot rests, where applicable.

Financially sustainable communities will require:

- ♦ adequately funded public services with the costs fairly shared with all levels of government
- ♦ a population that practices "shopping locally" in support of cottage-country merchants and farm-gate vendors
- ♦ a long-term strategy and funding to keep our infrastructure (roads, bridges, dams etc.) in good repair
